



The undersigned (hereinafter called Applicant) hereby applies for one or more of the following services provided by Mayfield Electric & Water Systems: electricity, water, sewer, or security light.

1. The Applicant agrees to comply with and be bound by all the rules, regulations and city ordinances relating to the type of service or services requested in this application.
2. The Applicant will, when such service or services have been made available to the premises described below, pay monthly rates as determined by action of the Mayfield City Council and the Mayfield Electric Plant Board and as shall be revised from time to time by these governing bodies.
3. The point of delivery for the electric system shall be the weatherhead. All wiring, piping and appliances beyond the weatherhead, other than the electric meter, shall be installed and maintained by the Applicant. The electric meter shall remain the property of Mayfield Electric & Water Systems. The point of delivery for the water system shall be the meter. All piping and appliances beyond the water meter shall be installed and maintained by the Applicant. The point of delivery for the sewer system shall be the cleanout. All piping and appliances beyond the sewer cleanout shall be installed and maintained by the Applicant.
4. Mayfield Electric & Water Systems assumes no duty or liability for injuries to persons or property resulting from wiring, piping, or appliances installed by the Applicant on its side of the delivery point. The Applicant hereby releases and agrees to hold harmless Mayfield Electric & Water Systems from any and all claims for injuries to persons or property occurring on the Applicant's side of the delivery point.
5. The Applicant hereby grants and conveys unto Mayfield Electric & Water Systems, the right and privilege to construct, operate, and maintain, together with the right of ingress and egress, service lines and appurtenances, either overhead or underground, over and across the land of the Applicant.
6. The Applicant agrees to pay all cost of collection including attorney fees, collection fees and contingent fees to collection agencies of not less than 35%, such contingency fee to be added and collected by the collection agency immediately upon your default and our referral of your account to said collection agency.
7. One year minimum contract required for security light and pole rental.
8. I agree to indemnify and hold harmless MEWS, its employees and agents, for any and all losses or damages incurred, be they real or consequential, including death, as a result of disconnection of services for nonpayment. I agree that my bill and disconnection notice will serve as sufficient communication as to what day my services will terminate.

I hereby certify that the above information is true and correct. I agree that my utilities may be terminated for a misrepresentation of any information on this application if the correct information would have resulted in a denial of service. I hereby consent to a consumer credit report check to determine amount of any applicable deposits or installation fees.
